1. WELCOME WORDS

Dear Seminar Attendants,

It is with great pleasure that I welcome you to the EURASHE seminar on the implementation of internal and external quality assurance at higher education institutions, and to European University Cyprus.

European University Cyprus is hosting this EURASHE event, with the support of Open University of Cyprus, under the auspices of the Cyprus Presidency of the Council of the European Union, as an official event of the Cyprus Presidency. Cyprus Presidency has appropriately put Quality Assurance (QA) as one of its priorities to be dealt with, which will also be a focus at the Directors General meeting next month. This shows that QA is high on the agenda at policy level, but also at higher education institutions, universities and colleges alike, something that is also underlined by the contributions to the Seminar of both the European Commissioner for Education, Culture, Multilingualism and Youth, and the Minister of Education and Culture of the Republic of Cyprus. Latest Communiqué (Bucharest) of the Ministers of the European Higher Education Area (EHEA) acknowledges the shift of focus to the implementation of the Bologna objectives; it is no coincidence that QA is primordial in this, for there are few things that preoccupy more the institutions than just a concern for quality, equally shared by management, students and teachers. Heads of institutions see quality as a foundation for positioning their institution, students aim at personal development and for acquiring the right skills and competencies that match their expectations, and teachers, who are the lever to achieve this, want to see their contribution recognized.

A student-centred learning approach is the true answer at the present educational and socio-economic environment, and we all realize that we still have a long way to go to fully achieve it. The European Standards and Guidelines (ESG), which are the heart of QA, were developed precisely to serve as a guide for institutions and QA agencies to help them monitor and enhance quality. It has always been the very specific input of EURASHE, as the official voice of professionally oriented higher education, to involve the stakeholders in this process, a focus that has gradually become recognized by others as well.

We particularly value here, the contribution of two of our E4 partners, a representative of ESU and the Vice Chair of ENQA, as well as the Vice Chair of the Register Committee of EQAR, precisely the same experts who together with EURASHE and EUA have embarked on this challenging exercise of preparing a revision of the European Standards and Guidelines.

We welcome a broad range of attendants, in the first place those who are the main target group for this seminar, namely the people coordinating and overseeing the implementation of QA at higher education institutions, but also stakeholders and government officials, with expertise and interest in what really goes on at the institutions. We will also hear today the voice of the European Commission, which has continuously supported this main priority area of the original Bologna Process.

The input for this seminar has been extremely diverse, and the programme bears witness to this: there are the conclusions and recommendations from our broad survey among member institutions and various stakeholders on the implementation of the ESG for QA at institutional level; there is the summative policy paper on *QA and Transparency Tools* resulting from discussions in our members forum of policy makers, which is the Council of EURASHE, and further elaborated by EURASHE's Working Group for QA, which took the initiative for this seminar; finally there is a concept for a manual/guide for QA proceedings at higher education institutions, a work in progress, as we want to further develop it with your input during this seminar.

The large showing up of such a mixed and broad audience from more than thirty counties within and outside Europe for what was intended to be a hands-on training seminar is now a gathering of the 'community of practice' in QA, which shows that we have hit the right cord with this initiative, and we hope that every single attendant will have the opportunity to be benefitted and also contribute to it.

I wish you a stimulating seminar.

2. RATIONALE OF THE SEMINAR

Background and Purpose of the seminar:

The European dimension of QA starts from a guaranteed flexibility for governments to choose their system or 'model' of QA, while observing the generic Standards and Guidelines for QA, which are universally used in all European institutions of higher education conducting their own Internal quality assurance (IQA) and/or being subjected to External quality assurance (EQA) by agencies, next to the latter's use for their own quality purposes.

With the targeted attendants (from our members institutions, but also from a wider background of policy makers and QA practitioners) we want to bring together a 'community of practice', which will be guided through the proceedings on the basis of a guide which has been developed by practitioners and policymakers, on the basis of their own expertise and relying on the feedback received through the extensive consultation among our membership and beyond this.

The ultimate objective with this hands-on seminar is to train individuals who are responsible for the management or coordination of IQA at institutions (e.g. QA managers, QA coordinators, QA administrators, etc.), so that after the completion of the seminar they will have acquired the foundation for organising and implementing fully, efficiently and effectively IQA based on the ESG, preparing them in this way also for the EQA evaluation of their institution.

Proceedings of the Seminar:

EURASHE as a European members' organisation with a broad representation in the majority of countries in the EHEA has committed itself to provide hands-on support to its member institutions and other interested parties in the priority areas of the Bologna reform process.

This was the logical consequence of the creation of the EHEA in 2010, where the focus has shifted to implementation of the 'Bologna achievements' on the institutional level.

In spite of (and we would even say, also because of) the economic crisis more expert hands-on support is needed for institutions for implementing Bologna tools such as quality assurance proceedings, learning outcomes, qualifications frameworks, etc. Secondly, a general need is felt for a forum for practitioners on the institutional level, where expertise and experience on those tools and instruments is shared and exchanged, with practitioners from Higher Education institutions.

This first of a series of seminars, focusing on internal and external quality assurance could thus be considered as a useful addition of the annual gathering of policymakers and QA assurance coordinators at the European Quality Assurance Forum (EQAF, of which EURASHE is a co-organiser with its 'E4' partners), and the training seminars for participants in external review teams.

QA has always been and remains a major interest for EURASHE, given our prominent role in the development of the ESG, and secondly given our role in the establishment of the European Register for Quality Assurance agencies (EQAR), always in close cooperation with the other E4 partners, namely ENQA, EUA and ESU.

These seminars are intended for institutions and programmes for whom review exercises do not provide the exchange of experience with colleagues in similar contexts. The workshops will therefore evolve around tools that may guide institutions in developing their own IQA proceedings (including

the PROSE initiative: www.prose.eu) and secondly the ESG for QA as a generic set of guidelines for QA, which provide the broader background and link IQA to EQA and to the work of the QA agencies.

The first day of the seminar starts with a plenary session, in which keynote speakers will introduce the overall theme by presenting briefly the most striking conclusions of the EURASHE survey on the implementation of the ESG for QA in the Higher Education Institutions and programmes with a 'professional orientation', and the joint E4 report with shared conclusions and recommendations to policymakers and stakeholders, following the separate consultations with their respective constituencies.

We will in a logical sequence of events then group attendants in workshops that will either focus on practical issues related to the *Implementation of IQA*, based on the ESG; the relevance and applicability of the ESG for institutions with a professional orientation and an address to the general public not aware of the ESG (intermediate level).

On the second day, in the plenary session the 'research aspect' of QA in institutions will be dealt with (as part of the overall mission of a Higher Education Institution), next to the presentation of a Tool for institutions implementing QA, the PROSE initiative for IQA before breaking out again for hands-on workshops. These workshops will focus on how to implement the PROSE tool, while adapting it to the needs of individual practitioners in the institutions; on the complementarity of (international or domain-specific) professional labels with the ESG; and on how to move forward with the ESG, after consulting with the institutions.

The workshops will be conducted and/or chaired by experienced members of EURASHE's working group for QA, who provided the necessary input for our QA policymaking and implementation.

5. INFORMATION ON THE SPEAKERS



Andreas G. Orphanides

Andreas G. Orphanides is the President of EURASHE, the Rector and Professor of Humanities and Social Sciences of European University Cyprus, ex-President and ex-Vice-President of the EQAR Board, and a Member of the Rectors' Conference of Cypriot Universities. He is also a consultative member of both BFUG Board and BFUG, and a member of the E4 Group. Professor Orphanides had/has served as the Assistant Director of the Institute of Cypriot Studies at SUNY at Albany, as Assistant Director of the Archaeological expedition in Cyprus of SUNY at Albany, as Vice-President of ECSA-Cyprus, as member of the Ad-Hoc Committee on Cyprus' Higher Education, and as member of the Preparatory Committee for the establishment of Open University of Cyprus. He served at university administrative positions at all levels. He has a significant research record, has published several books and journal articles, as well as articles in daily Press, and has presented papers in several international conferences. Apart from his academic and administrative activities, Prof. Orphanides has systematically been working creatively with music composition and poetry. He created and published four CDs, and he composed four major symphonic works, over 25 songs (including the lyrics), and the anthems of two universities (including the lyrics).



Androulla Vassiliou

Androulla Vassiliou is currently European Commissioner for Education, Culture, Multilingualism, Youth and Sport. Previously, she served as Commissioner for Health, from February 2008 to end 2009. Ms Vassiliou studied law and international affairs in London and practiced law in Cyprus for 20 years (1968-1988). During this period she acted as legal advisor to The Standard Chartered Bank and, later, to the Bank of Cyprus. Androulla Vassiliou was active in the field of international affairs and human rights as a President of the UN Association of Cyprus from 1978 until 1992 and as President of the World Federation of UN Associations from 1991 until 1995. She was unanimously elected Honorary President of the World Federation at the end of her term. Ms Vassiliou was also President of the Cyprus Federation of Business and Professional Women from 1996 until 2000, Vice-President of the ELDR and chairperson of the European Liberal Women's Network (2001-2006). George Demosthenous

Professor George Demosthenous, Minister of Education and Culture of the Republic of Cyprus, obtained the Diploma of Mechanical Engineering and a Doctorate from the National Technical University of Athens, Greece. In his previous position as Vice-Rector of Frederick University he was responsible for the development, operation and evaluation of all new undergraduate, postgraduate and doctoral programs of study. He was also responsible for the program review and re-evaluation of all programs of study of the University and has collaborated with the University's Internal Quality Assurance Committee on matters relating to teaching evaluation of the academic staff and the advancement of effective teaching methods and technologies. He was systematically involved with issues pertaining to quality assurance in higher education. From his research work a large number of publications have been published in international scientific journals and conferences. He also is the co-author of two scientific books. Professor George Demosthenous is the President of the Foundation for the Management for the European Lifelong Learning Programmes and a member of the Cyprus Scientific Council.



Fiona Crozier

Fiona Crozier is currently one of the two Vice-Presidents of the European Association for Quality Assurance in Higher Education (ENQA) Board, serving since 2008; she also serves on the ENQA Review Committee. Fiona Crozier is an Assistant Director, Development and Enhancement Group of the UK's Quality Assurance Agency for Higher Education (QAA) which operates in Gloucester, United Kingdom. Fiona Crozier's keynote contribution will be a "Discussion of the ESG, the ESG Survey and the E4 Joint Report & ENQA's Point of View on ESG Implementation".



Lucien Bollaert

Lucien Bollaert, Member of the executive board of the Accreditation Organisation of the Netherlands and Flanders (NVAO). Since 2009 Lucien Bollaert has been a member of the executive board of NVAO in The Hague. Before this he was acting general director and director of education and research at the University College of West Flanders (Belgium) and chair of the experts' committee on quality assurance of the Ghent University Association. He was member of the E4 group which developed the European Standards and Guidelines for Quality Assurance in Higher Education (ESG) and the European Quality Assurance Register for Higher Education (EQAR); he has been vice-chair of the EQAR Register Committee since its establishment in 2008. He has been a member of the organising committee of the European Quality Assurance Forum (EQAF) throughout the life of the Forum. He was also member of the first experts' working group on the European Qualifications Framework (EQF). For many years he was the Flemish Bologna expert on quality culture, quality assurance and learning outcomes. Mindaugas Misiūnas

Mindaugas Misiūnas holds doctoral degree in Social science (Kaunas Vytautas Magnus University) and master degrees in Mechanical engineering (Kaunas University of Technology) and in Social science (Kaunas Vytautas Magnus University). Mindaugas Misiūnas has experience as an expert in the external evaluation of higher education institutions and study programs. He was involved in several national work groups on quality assurance and other topics. He contributed as an expert in a work group for creating provisions of quality assurance in higher education and for creating methodological recommendations for the creation and implementation quality assurance systems. Mindaugas Misiūnas is also an expert of the Centre for Quality Assessment in Higher Education in external quality assessment of higher education institutions in Lithuania. Mindaugas Misiūnas participated in numerous European seminars and conferences on quality assurance. He is a member of EQAR Register Committee, Vice-president of Kaunas Chamber of Commerce, Industry and Crafts.



Pascale De Groote

Pascale De Groote was appointed as vice-chancellor of the Artesis University College in Antwerp, Belgium in January 2012. She has been Dean of the Royal Conservatoire of Antwerp (Artesis University College of Antwerp) since 2001; as well as being a lecturer of Dance History in the University of Antwerp. She has been active in the field of Quality Assurance since 1999, first as coordinator Quality Assurance of the Royal Conservatoire of Antwerp (until 2002), as inspector for 'Dance' in secondary education (2003-2010) and since 2004 as chairman or member of expert committees for review visits for bachelor and master programmes in dance, drama, music and related subjects (19 programmes in Belgium, the Netherlands, Estonia, Austria, and Switzerland). Pascale De Groote is a frequent member (or chairperson) of the board of directors of institutions active in arts, artistic research or art education (e.g. Studiecentrum voor Vlaamse Muziek, deFilharmonie, Antwerpen Open) and committees concerning educational matters in all levels of the art education in Flanders



Nicolae Dură

Nicolae Dură is Former Vice Rector if the "Ovidius" University of Constanta, Romania. He did studies in theology, philosophy, canon law, civil law, history, history of ancient juridical European institutions, history of ancient European culture (Greek, Latin, Ethiopian, Romanian etc.), and he graduated with High Honours with a major in Theology, Byzantinology, Law, Philosophy and Ethiopian Studies. He holds a PhD in Theology and Utriusque Juris Doctor (Civil and Canon Law). He is visiting professor at the University of Toulouse (France – for the Masterat and Doctorate). He is Editor-in-chief of the Annals of the "Ovidius" University, series: Law and Administrative Sciences; and has also been awarded the French "National Order of Merit" in June 2001 by

President of France, Mr Jacques Chirac, for his publication on "Le Régime de la synodalité selon la législation canonique, conciliaire, oecuménique, du ler millénaire" (Synodality system according to 1st Millennium ecumenical legislation) Bucharest, 1999. He was rewarded also with DHC at two Universities (Ukraine and Bulgaria). For his scientific works, he was also honoured by the Romanian Academy (Prize Xenopol), by the Jurist Union of Romania (Prize Manolescu), by the Bulgarian Patriarchate, Russian Patriarchate, Romanian Patriarchate etc. He was also honoured as Citizen of Honour of one city of Romanian and one of Bulgaria. As a leader of the doctoral school of the University Ovidius of Constanta for the Law and Theology Faculties, professor Nicolae Dură granted over 10 doctoral titles to his disciples.



Andre Vyt

Andre Vyt is associate professor in behavioural sciences at the departments of health care and rehabilitation sciences (Artevelde University College & Ghent University) and responsible for quality management and research in teaching and learning in the department of teacher education (Artevelde University College). He is founding partner and managing director of PROSE, an expertise network in quality management. During his career he has held different positions: researcher, lecturer, head of teaching & learning support services, institutional quality manager, financial manager for student services and logistics, head of research & development, academic board member, and between 1999 and 2003 he was vice-chairman of the working group on quality management of the Flemish Higher Education Institutions Council. He has managed several innovation projects in teaching & learning and has participated as an expert in more than 50 (national and international) auditing visits in higher education. His main focus is on integrative quality management, innovation, educational design, inter-professional education, and distance education.



Armelle Motte

Armelle Motte has 20 years in Higher Education experience, with both teaching and administration experience at the University Institute of Technology (IUT) at the University of Le Havre, France as Director of the Business Studies Department for 9 years. Moreover she has been President of the executive board of the national Association of Department Directors since 2007. She has been a member of a national experts committee appointed by the French Ministry of Research and Higher Education, in charge of auditing IUT departments and coordinating the evaluation of the DUT degree since 2007.



Brigitte Noc

Brigitte Noc has 15 years of experience in Higher Education, with both teaching and administration experience. Fernando M. Galán Palomares

Fernando Miguel Galán Palomares (Segovia, 1986) is a medical student at the University of Cantabria (Santander) and has been at the Università Degli Studi di Bari "Aldo Moro" (Bari, Italy), within the ERASMUS programme. Since he began his university education has been involved in various tasks of student representation. Within his university he has been student representative at the Faculty Board, the Council of the Medical and Surgical Sciences Department and the University Senate, besides being part of various committees and executive committee of the Student's Union at his university. He is also the representative of EURASHE in the 'E4' Group (with ENQA, EUA, ESU), which received mandates from the 'Bologna ministers' to harmonise Quality Assurance through the creation of European Standards and Guidelines for Quality Assurance, and has been a member of various Advisory and Expert groups of the European Commission and of stakeholders organizations in higher education (Cooperation with Enterprises, Innovation, the construction of the Integrated Lifelong Learning Programme, and the reform of the Jean Monnet programme, and the AHELO

project of OECD). Mr Delplace is a graduate of the University of Ghent (Languages and Business studies), and spent some time teaching (in-service training for companies, continuous education). He has run an international office of a University College for over 15 years, before specializing in policy towards and activities with partner countries of the EU (Tempus-Tacis & MEDA), and more recently in the implementation of the Bologna Process. Mr Delplace is fluent in French, Dutch, English and German.



Terence Clifford-Amos

Dr Terence Clifford-Amos is an International Consultant who has more than twenty years' experience in higher education, as a lecturer, researcher and senior administrator. He is experienced as a politician and civic leader, having been elected to the office of Mayor and Speaker of the Cinque Ports in the UK. Both roles committed him to senior leadership, management and administration in several areas of local government. Widely experienced in civic life, he has worked with members of parliament and liaised with the Speakers of the House of Commons and House of Lords, Westminster, He has worked on many local government projects as Chief Executive of Sandwich Town Council and was pivotal during the Pfizer industrial crisis of 2011. Throughout this crisis, as the most senior local politician, he attracted considerable local media and national press coverage. Terence has made several appearances on television and delivered numerous radio broadcasts in several overseas countries and in the UK. Highly experienced in international quality assurance and higher-education reform, he has worked with ministries of education, universities and various highereducation agencies. During his career in higher education, he has: made significant contributions to Arts, Humanities and Initial Teacher Education; been a visiting Fellow of Oxford and Cambridge Universities; Dean of Students and Head of English in the UK; and guest-lectured at Oxford and many UK universities. Currently, he is visiting scholar to the Université Catholique de Lille, France. 



Testimonial from a Head of an institution in the implementation of QA proceedings, Based on the ESG for QA, and Other Instruments for QA with a Professional Connotation

Abstract:

QA in an institution can't be limited to a system aimed at obtaining (external) accreditation, but must first and foremost aim at maintaining and enhancing the quality itself. Only if an institution is impregnated with quality assurance and develops a culture that penetrates in all its levels, QA can become an instrument for policy making. Therefore QA can't be the prerogative of QA specialists, but has to get implemented in every fibre of all involved in the making and executing of the institution's policy. This is only possible when QA is not imposed as a monolithic system, but if it is translated to the specific needs of every section. In doing this, using discipline specific frameworks and standards proves to be a real asset.

Title of contribution:

Quality Research at HEIs

Abstract:

At the Ministerial Conference of the European Higher Education Area, which took place in Bucharest between 17 to 19 October 2011 - which was attended by stakeholders and ministers of education from about 50 European countries, where the leaders of our organization (EURASHE) were also present, represented by its President, Prof. Andreas G. Orphanides, Vice President Michal Karpíšek, and its General Secretary, Stefan Delplace, - it was remarked that the European Higher Education is found at the crossroads: between the Bologna Process and National Reforms (See A. Curaj, P. Scott, L. Vlasceanu L. Wilso, European Higher Education at the Crossroads. Between the Bologna Process and national Reforms, Ed. Springer, Bucharest, 2012, p. V-VI.). In other words, the process of the implementation of Quality Research does not have to be only in line with the priority areas of Bologna Process, but also with the National Reforms. The European dimension of Quality Research starts not only from a guaranteed flexibility for governments to choose their system or "model" of Quality Research - as it is often said - but also from the implementation of Internal and external criteria of this in line with the priority areas of the Bologna Process as well as with the National Reforms.

Developing an Integrative Quality Management Policy and System with Links to ESG

Abstract:

In the plenary session, an overview is given of the principles of Integrative Quality Management (IQM) and the necessary steps for developing a QA system in which the ESG are embedded. Using the PROSE model, a step-by-step approach is demonstrated in developing a Quality Management handbook, according to the basic functions of QM: determination, assurance, improvement, and accountability. Starting with a communication and documentation inventory according to the 6P-model, we move on to key responsibilities and performance indicators, diagnostics and assessment procedures, improvement planning, and reporting.

Abstract:

Practical examples will be given, linked to ESG. In the workshop, a hands-on exercise with the PROSE Toolbox and the PROSE Online Diagnostics & Documenting System (PODS) is given, for the practical development of a Quality Management System. The workshop demonstrates the possibilities of the system, not only in performing team-oriented self-assessments, but also in prioritizing items for improvement, collaborating on improvement plans, and defining evidence for good practice and quality indicators. Participants are invited to bring their laptop.

Professional Labels and the ESG: Complementarity or Conflict? "Quality assessment in the University Institutes of Technology: an original process in the French University system"

Abstract:

Our presentation will deal with the auditing process and quality assessment in the French University Institutes of Technology. Since the mid 1960s, the University Institutes of Technology have been training middle engineers and managers, with national curricula combining both a strong academic background with professional training in engineering and the service sector. The Institutes have a long history of successful partnerships with the corporate world, which is closely involved in the Institutes' governance, the definition of curricula and the quality assessment process. The Institutes of technology have developed an efficient network of organizations both at the pedagogical and institutional levels. Thus the auditing process results from procedures and national experts' committees jointly established by the Institutes' network and the French Ministry of Research and Higher Education. The indicators that are surveyed range from the analysis of the environment, the implementation of the curricula, student achievement and professional integration to the strategic policy, relations with the university and general management. From the internal audits to the final experts' conclusions, the evaluation system allows the Institutes to be responsible actors and a driving force in Higher education.
