SUMMARY NOVELS OF MOHAMMAD FAREED ABU – HADDED

The Paper Summary :

This paper purpose was to study and analyse the novels of Mohammad Farred Abu-Hadded, Since this type of art, i.e. the art of novel, did not attain what it merits or deserves the adequate deal of researching, investigation or analysis by the former critics, analysts or specialists. This research involved an introduction, preface, five chapters, conclusion, and an index involving the sources and references. Regarding the introduction, it involved the reasons and drives that make me undertake this subject by studying and analyzing. Moreover, in the introduction, I explained and clarified the methodology I adopted in analyzing the novels which I have selected from among several novel works written by the writer. In my study, I have adopted another different and distinct methodology to or other than those methologies utilized in past. I have studied the romantic works of "Abu-Hadeed by the aid of the structural methodology when analysing the romances. This methodology is the one that views the literar work as a separated and isolated world both from it creator and recipipent or reader. The structural criticism or analysis persuades and urges the specialists to deal with the literary as if they were text whose authors have died, as well as this methodology is seen as descriptive and based on no judgements making. Concerning the preface, it included a concise lines portraying his emergence, his life and his education or bringing up in rapid way leaning on the fact that the extravagation or prolixity in the speech about the humanitarian area of the writer does conflict with the nature of the methodology chosen by me in this study, since the principal objective of my study about the novels of "Mohammad Farred Abu-Hadded" was just the novels themselves and not the writer or his related private morever, I have pointed to the posts in which "Abu-Hadeed graduated, the works he wrote, and the dates of what compose individually. If followed the preface by five chapters, each

As for Chapter I:

Starting the chapter with ateorition for the biography, motivations of writing about the self, and characteristics of a biography writing, and explained and clarified.

I have also referred to and defined the drives that stimulated urged, and caused Abu Hadeed to write out his biography, and followed this by making a structural analysis for each novel, by which I analyzed: (The narrator), (Enumeration language), (Enumeration pronouns), (Narrating stylel), (characters' language), (Age or epoch) and (the functional units of emuneration). Chapter 2:
