The first axis: God existence

This variable dealt with the talkers' terms of Existence in verifying God existence, but before reviewing these terms, the researcher has to demonstrate the knowledge of God existence, elucidate his existence to be oneness and has no partner.

God existence issue has received considerable attention of many researchers and thinkers specially, Talkers who concentrated in this issue on the intellectual discourse based on evidences.

Talkers deduced on showing the existence of God (ALLAH glory be to him) according to 4 faces:

- Deducting that substances are Contingent: that's to say that the substantial existence or the self tendentious is accident and that every accident has a causative.
- Deducting that substances are possible: as it is composite and should have an effective cause.
- Deducting Contingency of accidents.
- Creation and disposition rules:
- In self what we see in sperm transform to leech then embryo after that flesh and blood, these events should have an effective and wise creator.

Talkers in existence doesn't agree that God known as a necessity but some of them believe to be realized through vision and deduction so they are interested to be a necessity, those who say he the God can be realized through deduction that not because he needs people with Good nature but that deduction can help believers to seek help with in confronting the disbelievers who deny the wise creator of the world.

The current study dealt with these criteria in the following points:

1. Knowing God in talkers.
2. Verifying God Presence and his oneness in talkers.
3. Terms of the talkers in God existence.

Of the most main terms talkers used in the first axis "God existence":

(Vision - Knowledge – Contingence – Substances – Accidents – Duty – Possible – Role – Sequence - Corps).

The second axis: "terms talkers used in natural physical existence"

The chapters of this axis are called natures, talkers searched in the objects of the existence and its natural entity of motion, quietness, existence, nonexistence, bias, and the indivisible part and reached a comprehensive vision based on a group of pure intellectual principles so called "the accurate discourse".

Talkers' research based in searching in accurate discourse issues on an approach of the God through which they can understand and interpret the existence rather than the Greek philosophers and their followers of Muslim philosophers who based on the existence to understand and know God, and this is the base of the methodological difference between Talkers and Philosophers.

Takers in their deduction based on the dialectical approach contains any kind of mathematics, but on Arabic elucidation that rely on their language, then their Arabic language replaced mathematics, also they mixed their search in substance natures with their search in God existence and his, and their efforts aren't to look on nature and discover its principles and traditions but on verifying God existence, his characteristics and abilities.

The researcher in this axis dealt with the following points:

- Atom doctrine in Greek.
- Individual as a Substance in Talkers (atom).
- Individual Substance theory and his relation to the existence archaic or incidence and the ancestor point of view.
- The most important terms in the Talkers of physical existence are:
 - Individual substance.
 - Body.
 - Motion and stillness.
 - Bias

Abstract

The current study aimed to show the most important terms used by Talkers in Existence either The axis of God Existence or The axis of natural physical Existence, show the similarities and differences between Talkers in their terms with the general semantics of language, and show the Talkers approach in their physical search on dialectical approach not mathematics which replaced with their Arabic language.

To show the extent Talkers mixed their search in God characteristics with their search in nature Building on their inclusiveness vision of their handled issues according to the theoretical approach of induction.

Show the terms that Talkers used in verifying God Existence, most of which was philosophical terms.
